<p>I give my child permission to participate in Rock The Block Dance and Circus and understand that he/she will undertake physical activity. I understand that participation in Rock The Block Dance and Circus activities involves risk of injury and/or loss and damage to my property and that I participate in Rock The Block Dance activities at my own risk.</p>
<p>I release the teachers and organisers from all indemnity whilst my child is participating.</p>
<p>I consent Rock The Block Dance and Circus to use my, my child or ward's, photographic image or words for promotional purposes. I assign any and all rights, to Rock The Block Dance and Circus.</p>
<p>I understand that if my child chooses to leave, I must give 1 week notice to the principal of Rock the Block Dance and Circus through letter, email, phone call or by person of the withdrawal or I will continue to pay fee's and other charges until Rock the Block Dance and Circus has been officially notified by me</p>
<p>Knowledge - I understand the choreography my child learns at Rock the Block Dance and Circus is not to be used or performed outside of Rock the Block Dance and Circus unless written permission has been given by Rock the Block Dance and Circus. If you choose to leave the studio you are in no way to use or share Rock the Block Dance and Circus choreography.</p>
<p>Identification – You may not use Rock the Block Dance in a manner likely to deceive or cause confusion or jeopardise it's distinctiveness. Rock the Block Dance and myself and child agrees to refrain from using the identification of each party in association with or in relation to any activity, which reflects, or is likely to affect adversely or detrimentally the goodwill and reputation of the other party and not to engage in any conduct, which does or may be likely to have such effect.</p>
<p>I understand Fees must be paid in full in advance either weekly, monthly or by term and all missed classes must be paid for</p> <ul style="list-style-type: none"> ▪ Weekly - Payment must be made the first day of the week your child is at dancing ▪ Monthly - Payment must be made on the first Monday of every month ▪ Term – Payment must be made within the first 4 weeks of term. A 5% discount will be awarded if paid within the first 2 weeks of term
<p>If payment has not been made by week 4 of the term, your child will no longer be able to take part in classes until payment has been made in full to date. A \$25 late fee will be charged to your account.</p>
<p>I understand that all costume and class fee's must be paid up to date before the end of year concert or your child will not be able to perform</p>
<p>Classes must be paid for whether in attendance or not. A doctors certificate is required if you wish to be credited</p>
<p>Students are not permitted to play in our studio car park area. Please take care when driving into car park area. You are to walk your child into dancing and pick them up for safety reasons. Please pick up your child directly after their class.</p>
<p>No eating or drinking inside the studio. There is a fridge available to store drinks in. NO SOFT DRINKS IN THE STUDIO!</p>
<p>If you decide to withdraw from the concert after 17th August 2018, you are required to pay for all costumes in full price</p>
